

PEDIALYTE SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Pedialyte Sweepstakes (“Sweepstakes”) is sponsored by Abbott Laboratories Inc. (“Sponsor”), 100 Abbott Park Road, Abbott Park, IL 60064, and is administered by Prize Logic, LLC, (“Administrator”), Two Towne Square, Suite 200, Southfield, MI 48076.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on July 18, 2022 at 12:00 PM Eastern Time (“ET”) and ends on November 30, 2022 at 11:59:59 PM ET (“Sweepstakes Period”). The Sweepstakes includes fifteen (15) entry periods (each an “Entry Period”) as set forth in the chart below:

Non-winning entries will carry forward into subsequent Entry Periods. The Administrator’s computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of one of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, HMT Associates, Inc., Administrator, and each of their respective parent

An entrant may center the QR code in the camera and scan the QR code. Once completed, the entrant will receive a link to the Website, and may follow the steps noted above to enter the Sweepstakes. **An entrant cannot participate solely by scanning the QR code.**

Entry Limit: There is a limit of one (1) entry per person per day. If more than one (1) entry per day is received from the same person, telephone number and/or e-mail address the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities.
